


LOCATION MAP








ADJACENT PARCELS




ZONING DISPLAY MAP




GENERAL PLAN CLASSIFICATIONS


Coastal Zone Boundary Line



FORT BRAGG RURAL FPD







Western Soils S-G Complex







Legend: Marginal Water Resources




COASTAL GROUND WATER RESOURCE AREAS




HIGHLY SCENIC & TREE REMOVAL AREAS




Figure 1. Plant Communities Map.





LOADING SHED EXAMPLE


