**REQUEST:** Renewal for Minor Use Permit #U 2-2012 to allow the temporary use of a property for a 4-day event known as the "Redwood Run" to include camping, music, provisions for food and alcohol and vending booths. A total of 5,000 attendees would be authorized. Date of the event would be June 9th through June 12th of 2016.

**LOCATION:** In Piercy, lying on the west side of the Highway 101 and Highway 271 junction, and on the south side of CR 442B, extending to the Eel River, 2.75± miles south of the Humboldt/Mendocino County line. APN's 053-150-08, -02, -03, -18, -17 and 053-110-11.

Appeals to the Board do not guarantee that the Zoning Administrator's decision will be overturned. In some cases, the Board may not have the legal authority to overturn the decision.
